Rural Justice Issues



Access to Justice has reached a crisis in the US, Canada, and abroad. The Legal Services Corporation's 2022 Justice Gap Report reports that rural communities are particularly at risk. Approximately 8 million people living at or below 125% of the poverty level live in rural America. In Canada, rural communities within all of Canada's provinces likewise grapple with poverty and receiving access to justice. In this session, participants will develop:

- 1. A better understanding of the civil justice gap and its scope in the US and Canada;
- 2. The ability to identify the prevailing civil justice needs that are inadequately or entirely unaddressed within individual communities and reasons why;
- 3. Available resources external to courts employed to reduce the civil justice gap;
- 4. Existing court-initiated or court-involved solutions to eliminating the civil justice gap in rural communities.
