# MEMBERS IN THE MEDIA: THE HONORABLE DESIREE CHARBONNET!

The Atlantic's Eve Troeh sat down with District 6 Member Judge Desiree Charbonnet to discuss her utilization of diversion as an effective and dignifying tool to better address both the needs of the public and those of repeat offenders.

Congratulations to Judge Desiree Charbonnet for the impact she's making and the recognition she has received for it in the national media. Judge Charbonnet was <u>recently profiled</u> in *The Atlantic* for her development of court diversion tactics. Working with the ABA's Racial Justice Improvement Project and the Community Alternatives Program maintained by the City of New Orleans, Judge Charbonnet works tirelessly to ensure that the mentally ill defendants who appear before her have access to the treatment they need to help them stay out of jail. As Troeh notes in the article, getting defendants the mental healthcare they need saves the criminal

justice system so much that it could pay for itself.

Partnering with Women With a Vision, Judge Charbonnet started a diversion program for women charged in connection with sex work. Her program works by dignifying her defendants, giving them access to support networks, and even comes with a graduation ceremony at the end.

Congratulations to Judge Charbonnet, and thank you for all the work you do to make the justice system work for everyone, including women and other groups!

#### UPCOMING LOCAL EVENT: LOUISIANA WOMEN JUDGES


Please join me on the evening of **Monday, October 24, 2016** for an event with Newcomb College's Sally J. Kenney, <u>Why Courts Matter</u>, and Tulane University Law School. Via Newcomb College's website:

"A native of Iowa, Sally J. Kenney earned her a B.A. in Political Science from the University of Iowa, a B.A. and M.A. in Politics, Philosophy, and Economics from Magdalen College, Oxford, and an M.A. and Ph.D. in Politics from Princeton University. From 1989-1995, she held a joint appointment in Political Science, Women's Studies, and Law at the University of Iowa. She served on the faculty at the University of Minnesota's Hubert H. Humphrey Institute of Public Affairs from 1995-2009 where she also directed the Center on Women and Public Policy. She joined Tulane University in 2010 as the first Newcomb College Endowed Chair, the executive director of the Newcomb College Institute, and a Professor of Political Science. She is currently studying women state supreme court justice and advocating for more women on the bench. Her next research project is to work with women in prison, tackling the gender issues arising from mass incarceration, seeking clemency for battered women, and developing service learning courses with incarcerated women."

We will be discussing Sally J. Kenney's work on gender in the judiciary. I will send out an email with more details closer to the event.

The book is "[i]ntended for use in courses on law and society, as well as courses in women's and gender studies, women and politics, and women and the law[.] [T]his book explores different questions in different North American and European geographical jurisdictions and courts, demonstrating the value of a gender analysis of courts, judges, law, institutions, organizations, and, ultimately, politics. *Gender and Justice* argues empirically for both more women and more feminists on the bench, while demonstrating that achieving these two aims are independent projects."
