



At-Risk Adult Crime Tactics (ACT)

- Free, **2-day** training course for primary and secondary responders
- 6 students in first class in April 2011
- Classes of 80+ students recently
- Approved for 10 hours' Continuing Legal Education for attorneys
- Approved for 16 hours' Emergency Medical Technician credit
- 383 referrals to Adult Protective Services in FY2016. That number grew to 440 referrals in FY2017.



ANE Work Group

- About 100 professionals representing state, local and federal entities
- Designed to break down silos between law enforcement / social services / state and federal regulatory agencies
- Two subgroups the Financial Exploitation Work Group and the Legislative Work Group
- Instrumental in passage of House Bill 78, so that authorities can investigate alleged abuses of the elderly, including financial exploitation, as crimes



Financial Exploitation Work Group

- Financial professionals
- Law enforcement
- Prosecutors
- Certified fraud examiners
- The Attorney General's Medicaid Fraud Control and Consumer Protection Unit
- The Secretary of State's Securities Division
- Adult Protective Services





GANE App

Grew out of Financial Work Group meetings and summits.

Special features for law enforcement and other professionals:

- Temporary Emergency Respite Fund (TERF) tab
- Emergency placements by ZIP code
- Screening questions and algorithms
- Push notifications



Legislative Work Group

The Legislative Work Group was instrumental in the passage of the Uniform Power of Attorney (POA) Act (O.C.G.A. § 10-6B-1), which expands on requirements of what an agent is:

- Obligated to do (e.g., keep detailed records and receipts)
- Not allowed to do (e.g., use power of attorney to create a new Last Will and Testament for the principal)

Location of the law in the state code is very important for enforcement.



Legislative Work Group

Other legislative efforts:

- H.B. 72 (enacted 2015) allows cases to be tried in jurisdictions where victims live (O.C.G.A. § 16-5-104).
- H.B. 899 (enacted 2014) makes operating an unlicensed personal care home a crime (O.C.G.A. § 31-7-12.1).
- Future legislation includes a bill that specifically addresses benefits trafficking.



Case History – DeKalb County

Vulnerable victims:

- Elderly woman and son, both with health issues.
- Caregiver comes in to live with them.
- Later brings in relatives to help.
- Gains control of family finances, Power of Attorney.



Case History – DeKalb County


Alert response:

- Caregivers make conspicuous withdrawals and purchases.
- Financial institution employee notices unusual, possibly unauthorized transaction.
- Adult Protective Services notified, begins investigation.
- Others who notice irregularities (such as manager of apartment complex) report them to APS.
