

The Honorable Sandra Ann Robinson Judge, State of New Jersey

JUDGE SANDRA ANN ROBINSON has been an attorney for forty plus years, which includes fifteen years as a Judge. She has worked for the Bergen County and Hackensack communities, as Bergen County Assistant County Counsel; Bergen County Adjuster; former Deputy Mayor of Hackensack, Councilwoman in Hackensack, Attorney for the Bergen County and Hackensack Municipal Planning and Zoning Boards, and Adjunct Professor of Legal Studies at Farleigh Dickinson University. Currently serving as **Of Counsel in the Law Firm of Barbara B. Comerford, LLC.**

Judge Robinson's involvements in community life include: Life Member of the National Association of Negro Business and Professional Women's Club, Inc., member of CarePlus Bergen New Bridge Medical Center Board of Directors, former member of the Girl Scout Council Board of Directors, Member of the Board of Governors of Hackensack University Medical Center, Life Member National Association for the Advancement of Colored People, former active member and attorney for the Bergen Passaic Chapter of the National Coalition of 100 Black Women.

Judge Robinson has received numerous civic and legal awards and honors. She is admitted to practice law before the bars of the Supreme Court of the United States of America; the Third Circuit Court of Appeals; United States District Court for the District of New Jersey; Supreme Court of the State of New Jersey; and the Supreme Court of the Commonwealth of Pennsylvania. She received a Doctorate of Jurisprudence degree from Howard University School of Law and thereafter clerked for a New Jersey Superior Court Judge.

She is a scholar of The Honorable Anne E. Thompson Inns of Court, a member of the American and the National Bar Associations, Kappa Beta Pi International Legal Sorority, other Bar Associations in New Jersey and a former Member of the Board of Trustees of the Bergen County Bar Foundation. Judge Robinson is a life member of the National Association of Women Judges' (NAWJ), past District III Director for New Jersey, Pennsylvania, Delaware and the Virgin Islands and a recipient of the NAWJ Mattie Bell Davis Award.

Interesting Tidbits about Judge Robinson: In the early 1960's she met with Rev. Martin Luther King, Jr. Minister and Civil Rights Activist, Rev. Ralph Abernathy, Fannie Lou Hamer, Cassius Marcellus Clay, Jr. a/k/a Muhammad Ali a former professional boxer considered the greatest heavyweight boxer in the history of sports, hugged the Late Nelson Rolihlahla Mandela who was a politician and philanthropist who served as South Africa's first black chief executive and President from 1994 to 1999. She knew Thurgood Marshall the first Black Associate United State Supreme Court Justice, as well as the Late Associate Supreme Court Justices Ruth Bader Ginsburg and Lewis Franklin Powell, Jr. who moved her admission to the United State Supreme Court Bar. Well known to her are Associate Supreme Court Justices Sandra Day O'Connor, Sonia Sotomayor and Elena Kagan who are members of NAWJ, where Judge Robinson currently serves as co-chair of the Audit and Compliance Committee.
