ACKNOWLEDGEMENTS and ANNOUNCEMENTS:

Long time member Judge Lora Livingston has announced that she will retire at the end of her term in December 2022. She has been the Travis County Local Administrative Judge since September 2020.

Judge Elisabeth Earle, County Court #7 (Travis County) is the new chair of the Judicial Section, State Bar of Texas. Founder of the court's DWI Treatment Court in 2008, she was elected by her peers and has been the Presiding Judge over County Court at Law Judges since 2011.

Judge Linda Chew, 327th District Court, will not seek re-election and will retire at the end of her term in December 2022. She is the Local Administrative Judge for the El Paso County Council of Judges since 2019.

Chief Justice Dori Contreras selected Chair of the Texas Council of Chiefs for 2021-2023. An NAWJ and founding member of Texas Latinx Judges, Chief Contreras is the first woman and Latina to serve as Chief Justice on the Thirteenth Court of Appeals. Likewise, she is the first Latina to serve as Chair of the Council. Chief Contreras was honored by the Hidalgo County Democratic Party on November 3, 2021, as the Democratic Woman of the Year 2021.

Senior Judge Orlinda Naranjo was awarded the Norma Wikler Excellence in Service Award by NAWJ at its annual conference held in Nashville, TN, in October 2021.

Judge Renee Rodriguez-Betancourt, 449th District Court, was appointed to the Texas Judicial Commission on Mental Health and the Meadows Mental Health Policy Institute.

Judge Victor Villarreal was featured in UT Austin's School of Law Celebration honoring its alumni for National Hispanic Heritage Month in October 2021. Judge Villarreal was president of the Chicano/Hispanic Law Students' Association, the largest in the U.S., and he created the Susana I. Aleman Scholarship while a student at Texas Law. Judge Villarreal is proud of his NAWJ membership and is a founding member of Texas Latinx Judges.

Judge Rosie Speedlin Gonzalez, County Court at Law #13 (Bexar County) was named one of the Most Fascinating People in San Antonio for 2021. She was also recently appointed to serve on Congressman Joaquin Castro's Military Service Academy Nominations Committee.

The Hispanic Issues Section, State Bar of Texas, recognized the following members:

Justice Leticia Hinojosa, 13th Court of Appeals, received its Reynaldo G. Garza Lifetime Achievement Award. Named in honor of the first Mexican-American federal judge who subsequently was appointed in 1979 to serve on the U.S. Court of Appeals for the Fifth Circuit, HIS recognizes Justice Hinojosa's contributions throughout her legal career to advance, support and open doors for others. A native of Brownsville, Justice Hinojosa was the first woman elected judge in South Texas and previously presided over Cameron County Court at Law No. 4 and the 139th District Court. She is an active member of local, state and national professional groups, she served on the Board of Texas Court Appointed Special Advocates (CASA) and was instrumental in establishing CASA in Hidalgo County. She was recognized by Governor Ann Richards for her exceptional community work as recipient of the Back to the People Award.

Judge Leslie Briones, Harris County Civil Court No. 4, received the James W. Wray, Jr. Founder's Award. The James W. Wray, Jr. Founder's Award, named for its first recipient, who vigorously advocated for the creation of Concerns of the Spanish Speaking Community, predecessor to this Section, will be presented to Harris County Civil Court at

Law No. 4 Judge Leslie Briones. A Laredo native, Judge Briones was a public school teacher there after graduation from Harvard University, before attending and being graduated from Yale Law School. She then was a litigator and tax lawyer at the Vinson & Elkins Law Firm, and has served as general counsel and chief operating officer of a national nonprofit organization. Presently, she is an adjunct professor at the University of Houston Law Center. She is the president and a co-founder of Texas Latinx Judges and Houston area co-chair of the National Association of Women Judges.



Chief Justice Rebeca Martinez, Fourth Circuit Court of Appeals, was named Judge of the Year. Chief Martinez graduated with honors from Incarnate Word Academy in San Antonio and was distinguished as a University Scholar at Southern Methodist University before receiving her law degree from Boston University School of Law. She presides over a court with jurisdiction over 32 South Texas counties. She is a former District Director and continues to support the District's activities and programs.
