# Overall District Report:

Many of our members throughout the District are continually engaged with local schools in teaching about the three branches of government. The judges give the students a closer look at the judiciary and what its role is in relation to the other branches of government. We have many active members throughout California, and we are up to 12 in Nevada. In the coming months, we hope to inspire our Central and Northern California, along with our sister members in Nevada to bring mentoring programs and re-entry programs to their courts and women's jail.

# HIGHLIGHTS FROM OUR DISTRICT: CHIEF JUSTICE PATRICIA GUERRERO MAKES HISTORY IN CALIFORNIA



Justice Guerrero was appointed by Governor Newsom as the first Latina Chief of California's Supreme Court. At the time, the new Chief commented, "there has never been a Latino or a Latina to serve as chief justice until now. I am proud to be the first, and I look forward to the second, third and the fourth." For all who know Justice Guerrero, this display of humility is her nature, and California is fortunate to have her serve as their Chief of the highest court, following the stellar leadership of Chief Justice Cantil Sakauye. Chief Justice Guerrero previously served on the San Diego Superior Court and then the Fourth District Court of Appeal before taking the highest judicial seat in the state.
