Hon. Kendra G. Bertschy

Kendra G. Bertschy serves as Justice of the Peace for Reno Justice Court, Department 2, having been elected in November 2022. She presides over criminal, civil, and specialty court dockets. In July 2024, with the support of the Reno Justice Court administration and civil team, Judge Bertschy established "Housing Court," a therapeutic eviction diversion court aimed at providing expedited rental assistance and therapeutic interventions to tenants in need. With expertise in both criminal and civil law, her legal career is rooted in a commitment to ensuring equal access to justice and addressing the needs of vulnerable populations.

Judge Bertschy graduated with Distinction from the University of the Pacific, McGeorge School of Law, and earned an Honors and History degree from the University of Puget Sound. In 2024, she completed the Judicial Executive Leadership Program through Harvard Law School's Executive Education. Her dedication to public service extends beyond the courtroom, having previous served as Chair of the Note-Able Music Therapy Services, the Northern Nevada Women Lawyers Association, and the Washoe CASA Foundation.

She currently serves as the Education Chair of Nevada Judges of Limited Jurisdiction and was appointed to the Nevada Statewide Commission to Study Judicial Branch Security and the Nevada Committee to Study Evidenced-Based Pretrial Release. Judge Bertschy also teaches at the University of Nevada, Reno. In her free time, she enjoys skiing and hiking with her dog.

Threats Against Women Judges: Why the Risk is Greater and How to Protect Your Home and Family

Threats and attacks against judges have escalated rapidly in recent years. But within this general climate of judicial hostility, it's important to understand that some judges are at higher risk than others. Our research has found that women judges and minority judges are also targeted at a higher frequency. Threats received by a judge that is a woman of color are typically 40% higher than those directed at a white male judge. The webinar will provide strategies judges can begin employing right away to better protect themselves and their families.

Understanding and Addressing Caste Discrimination in U.S. Courts



This National Association of Women Judges discussion on caste discrimination, featuring leading scholars, advocates, and practitioners was held June 12, 2025. The panelists provide critical insights into recognizing, litigating, and adjudicating caste discrimination cases. The session highlights developments such as the Fresno Resolution and the ABA's stance on caste equity, offering practical guidance for both attorneys and judges.

Caste discrimination, while long recognized internationally, is an emerging frontier for U.S. courts, attorneys, and advocates. This panel, hosted by the National Association of Women Judges, equips legal professionals with the knowledge to recognize caste discrimination, frame claims effectively, and evaluate these complex cases from the bench.

Panelists explore the foundations of caste as a social and legal category, share real-world examples of caste bias in the U.S., and discuss practical strategies for litigating and adjudicating these claims. The discussion also highlights key developments, including the landmark Fresno City Resolution and the American Bar Association's resolution recognizing caste discrimination as a form of prohibited bias.

Through this session, judges and attorneys will gain practical tools for identifying and addressing caste-based harms, and judges will deepen their understanding of how to weigh and evaluate evidence of caste discrimination under existing legal frameworks.

Ethical Legal Research with Generative AI

This presentation is for legal professionals who want a better understanding of the intersection between generative AI and legal ethics. Beginning with a foundational overview of AI and its generative capabilities, participants will explore the ethical implications as outlined by the American Bar Association (ABA) model rules. Key topics include maintaining competency (Rule 1.1), ensuring confidentiality (Rule 1.6) and effective supervision (Rule 5.1) in the context of AI use.

The course will also address potential sanctions for unethical AI practices and provide insights into the application of AI in legal research tools, emphasizing ethical principles and considerations. Participants will engage in discussions on specific ethical issues such as AI hallucinations, supervisory concerns, and confidentiality challenges.

The course concludes with a review of ethical AI use policies within law firms and an open discussion to consolidate learning and address participant queries. This course is designed to equip legal professionals with the knowledge and tools necessary to ethically integrate AI into their practice.
