# CAROL ROBLES-ROMÁN A WOMAN WARRIOR



On Sunday, August 20, 2023, the legal community suffered a tremendous loss when Carol Robles-Román died after a six-year battle with lung cancer at the young age of 60.

A Latina leader and champion of women's rights, Latino/a rights, educational access and good government, Carol Robles-Román was a force of nature. She was a Puerto Rican Bar Association member and board member of the Latino Judges Association Foundation. Her career spanned an exceptional breadth of experience in legal and judicial matters, government operations, higher education governance, and civil rights enforcement.

# CAROL ROBLES-ROMÁN A WOMAN WARRIOR

Carol served as New York City Deputy Mayor for Legal Affairs and Counsel to Mayor Michael Bloomberg from 2002–2013. In that role, she oversaw 13 agencies and managed a portfolio of essential legal and compliance matters ranging from administrative tribunals to ethics, civil rights, conflicts of interest, public records, and judicial selection.

Carol previously served as New York State Assistant Attorney General in the Civil Rights Bureau, as well as Special Inspector General for Bias Matters and Special Counsel for the New York State Unified Court System.

In addition to social justice and good government, Carol demonstrated an abiding commitment to academic excellence and opportunity. She served as a Trustee at the City University of New York from 2002 to 2016, where she chaired the Committee on Student Affairs and Special Programs and served on the Executive and Fiscal Affairs Committees, along with the Committee on Faculty, Staff and Administration.

Most recently, as General Counsel and Dean of Faculty at Hunter College, Carol served as its inhouse legal counsel. Carol supervised Hunter's Office of Legal Affairs and advised the President, college administrators, and faculty on a broad array of issues, including litigation, employment and labor law, governance, fundraising, contracts, real estate and regulatory matters, and administration and interpretation of CUNY bylaws.

Carol's leadership and contributions have been recognized by the many communities she touched. Yet, Carol's most important jobs were as a beloved spouse, mother, sister, and friend. Her two children were her proudest achievements. She is survived by the love of her life of over 40 years, her husband United States District Court Judge Nelson Román; her daughter Ariana and fiancé Phil; her son Andres; her beloved sisters Frances, Sally, Melisa, Edna; and countless friends who will forever miss her shining light, beautiful mind and energetic wit. Carol was a woman warrior.

# HON. DIANNE T. RENWICK: PRESIDING JUSTICE, APPELLATE DIVISION, FIRST DEPARTMENT



Hon. Dianne T. Renwick is Presiding Justice of the New York State Supreme Court, Appellate Division, First Department. Following the historic appointment by Governor Kathy Hochul, in June 2023, she is the first woman of color and only the second woman to lead the Court since its creation in 1894.

Justice Renwick began her legal career representing indigent criminal defendants as a staff attorney for the Bronx office of the Legal Aid Society's Criminal Defense Division. After honing her skills as a trial attorney, she was invited to join the Federal Defenders where she represented criminal defendants before the United States District Court for the Eastern District of New York.

# HON. DIANNE T. RENWICK: PRESIDING JUSTICE, APPELLATE DIVISION, FIRST DEPARTMENT

Justice Renwick's judicial career began when she was appointed a New York City Housing Court Judge in 1997. Later that year, she was elected as a Judge of the Civil Court of the City of New York. In 2001, she was elected as a Justice of the Supreme Court of the State of New York, in Bronx County. In 2008, Governor David Patterson appointed Justice Renwick to the Appellate Division, First Department, making her the first woman of color, and the fourth woman, ever to join the Court. She served as an Associate Justice until March 2023, when she became Acting Presiding Justice, serving in that capacity until her appointment as Presiding Justice.

As a jurist committed to improving the courts and legal profession, Justice Renwick also serves on the Board of Trustees of the Historical Society of the New York Courts, the Practicing Law Institute, and the New York State Permanent Judicial Commission on Justice for Children. During her tenure as an Associate Justice, Justice Renwick was Chair of the New York State Continuing Legal Education Board from 2009 to 2012, and inaugural Chair of the Anti-Bias Committee of the Appellate Division, First Department from 2020 to 2023. As Chair of the Anti-Bias Committee, Justice Renwick oversaw the historic installation of the sculpture, NOW, which for the first time put the figure of a woman on equal footing with the heretofore uniformly male sculptures of ancient lawgivers that adorn the courthouse roof.

Justice Renwick is the recipient of numerous awards, including the Jewish Lawyers Guild's Golda Meir Memorial Award, the Judges & Lawyers Breast Cancer Alert's Leadership Achievement Award, the Westchester Black Bar Association's Constance Baker Motley Award, and the Bronx County Bar Association's Judicial Recognition Award, to name a few.

A proud graduate of Cornell University and The Benjamin N. Cardozo School of Law at Yeshiva University, Justice Renwick was named Cardozo School of Law's Alumna of the Year in 2010 and had the honor of delivering the commencement address for the school's 35th graduation ceremony in 2013. She is a member of Cardozo School of Law's Board of Overseers and remains involved in the Cardozo community through organizations like the BALLSA (Black Asian Latino Law Students Association) Alumni Group. In addition, Justice Renwick, has served on Cornell University President's Council of Cornell Women, from 2006 to 2016, and as an Emeritus Member since 2016.

Justice Renwick is a lifelong resident of the Bronx. She was educated in the Bronx through high school at the Academy of Mount St. Ursula. Presiding Justice Renwick has an unshakable commitment to civic education and advancing issues of the bench, bar, and community. She has taught trial advocacy programs, mentors students, and serves on legal, educational and cultural boards and committees, including as longtime member of the Board of Trustees of the New York Botanical Garden. She remains committed to community service, particularly in the Bronx, where she resides with her family.

## 2023 SCALES OF JUSTICE ACADEMY, INC. JULY 10- 21, 2023



The 14th annual Scales of Justice Academy (SJA) session commenced on July 10, 2023 and returned in person at the Fordham University School of Law in Manhattan.

Due to the pandemic the SJA was conducted via Zoom on a Virtual platform in 2021 and a Hybrid system was utilized in 2022. Both sessions were successful legal educational programs attended by a total of forty-five (45) outstanding yet underserved female high school students. This current summer academy class schedule shall include, among others, the legal topics of Criminal Law, Domestic Relations Law, The American Jury System, Real Estate Law, Intellectual Property Law, Human Trafficking, Immigration law, Role of the District Attorney, Appellate procedures, Landlord Tenant Law, Domestic Violence, and the NYS Court System.

# 2023 SCALES OF JUSTICE ACADEMY, INC. JULY 10- 21, 2023

The Hon. Rowan D. Wilson, Chief Judge of the Court of Appeals and of the State of New York will welcome the incoming class of female high school academy students and conduct two (2) substantive lectures. Clinical Professor of Law Leah Hill has continued to be an integral part of the SJA and will address the students. Introductory remarks will be given by the Hon. La Tia W. Martin, Bronx Supreme Court Supervising Judge of the Matrimonial Part and Dafina Cobbinah-Pinckney, Esq. Guest lecturers include, among others: the Hon. Shirley Troutman and the Hon. Jenny Rivera Associate Judges of the NYS Court of Appeals, the Hon. Troy Webber and the Hon. Bahaati Pitt Associate Justices of the Appellate Division, First Department, Bronx County District Attorney the Hon. Darcel Clark. Our volunteer faculty members represent jurists from all levels of the NYS judiciary, law school deans, law school professors, public and private sector attorneys, a district attorney, state assemblywoman, and elected officials. The SJA was established in 2009 as a no fee precollege legal preparatory program for female high school students which conjoins course work of substantive legal topics and moot court sessions with leadership training skills.

To date over seven hundred (700) dedicated and well deserved young women from diverse backgrounds have successfully completed the training and support necessary as guidance through the "pipeline" entrance into law school. We have followed the progress of our graduates and witnessed them discover their potential and positive contributions. Many of the SJA students are either enrolled in or graduated from undergraduate colleges, universities and law schools throughout the nation. We are also proud to acknowledge that many SJA graduates are currently members of the legal profession.





• Congratulations to the **Hon. Christina Ryba** on her appointment as Supervising Judge of the Supreme Courts for the 3rd Judicial District which encompasses Albany, Columbia, Greene, Rensselaer, Schoharie, Sullivan and Ulster counties.




The Honorable Christina L. Ryba was elected by the people in the third judicial district to serve as Justice of the Supreme Court of the State of New York in 2015. Prior to beginning her term in 2016, she held various positions in the court system for the Office of Court Administration (OCA) and in the NYS Supreme Court Third Department Appellate Division including Special Projects Counsel to the Deputy Chief Administrative Judge for Courts Outside New York City and Special Projects Counsel to the Presiding Justice of the Appellate Division, Third Department. Before working with the judiciary, Judge Ryba was an associate at Nixon Peabody where she practiced Labor/Employment Law and Commercial Litigation. She also served as an Assistant Attorney General for the State of New York Litigation Bureau. Judge Ryba's additional public service includes appointments first as General Counsel and then as Deputy Director for the City of Albany Community Development Agency. She originally began her career in public service with the City of Albany Corporation Counsel's office.

Justice Ryba is the first African American woman elected to Supreme Court in the 3rd JD.

#### Fourth Department:

- Congratulations to **Hon. Deborah H. Karalunas**, who was appointed Administrative Judge for the Fifth Judicial District in June 2023.
- On September 21, 2023, the Eighth Judicial District held A Conversation with the Descendants of Plessy v. Ferguson, which was moderated by the **Hon. Shirley Troutman**.





Chief Administrative Judge Joseph A. Zayas recently announced the appointment of Hon. Deborah H. Karalunas as Administrative Judge for the Fifth Judicial District. The appointment was made with the approval of Chief Judge Rowan D. Wilson and after consultation with Hon. Gerald J. Whalen, Presiding Justice of the Appellate Division, Fourth Department.

In her new capacity, Judge Karalunas will oversee the daily operations of the trial-level courts in the Fifth Judicial District, which encompasses Herkimer, Jefferson, Lewis, Oneida, Onondaga and Oswego counties in Central New York. She is filling a vacancy left by Judge James P. Murphy, who earlier this month was named Deputy Chief Administrative Judge for Courts Outside New York City. Judge Karalunas was first elected to the Onondaga County Supreme Court bench in 2002 and reelected in 2016, handling a varied, complex civil caseload including commercial, personal injury, medical malpractice, intellectual property and environmental matters. She has served as the Presiding Justice of the County's Supreme Court-Commercial Division since 2007. Prior to her ascension to the bench, she was a partner at Bond, Schoeneck & King, having first joined the Syracuse law firm in 1983. She began her legal career as a law clerk to Chief Judge Howard G. Munson of the U.S. District Court in the Northern District of New York. She is a graduate of Syracuse University College of Law, where she was a member of the International Law Review, Moot Court and Justinian Honor Society.

Among her numerous extra-judicial activities, Judge Karalunas is a member of various bar associations, a former chair of the Fifth Judicial District's Women in the Courts Committee, a past president of the Association of Justices of the Supreme Court of the State of New York, a past president of the Central New York Women's Bar Association and a former presiding member of the New York State Bar Association's Judicial Section. Additionally, she is an adjunct professor at Syracuse University College of Law, where she teaches New York Civil Practice, and a member of the Committee on Pattern Jury Instructions. Her appointment is effective July 10, 2023.
