HON. JANICE A. TAYLOR ELEVATED TO THE APPELLATE DIVISION, SECOND DEPARTMENT

On June 13, 2022, NAWJ member the Hon. Janice A. Taylor, a Justice of the Supreme Court of the State of New York was elevated to the position of Associate Justice of the Appellate Division of the Supreme Court of the State of New York, Second Judicial Department, by appointment by Gov. Kathy Hochul.

Justice Taylor has served as a Supreme Court justice in Queens County since 1998 and reelected in 2011 for another 14 year term. Judge Taylor was elected Civil Court in 1994 until
her elevation to Justice of the Supreme Court in 1998. Justice Taylor is the Former
President & Current Chair Emerita of the Macon B Allen Black Bar Association, Former
President of the Supreme Court Justices Association of the City of New York, Former
President of the Queens Supreme Court Justices' Association and currently represents the
11th Judicial District in the Association of Supreme Court Justices of the State of New
York.

JANE M. BOLIN: A TRUE TRAILBLAZER

Around May of 2021, visiting law professor of New York Law School (NYLS) Lisa Grumet reached out to the NYC Law Department to inform that NYSL began partnering with the ABA Family Law Section to produce a scholarly publication called the Family Law Quarterly. Professor Grumet oversaw the publication and worked with the ABA and NYSL Student Editorial Board. The them for this issue was "family law legacies" inspired by the passing of Justice Ginsburg and was to include articles about several people who contributed significantly to the development of family law during their lifetimes. She asked if anyone at the Law Department had written anything about Judge Bolin who might be interested in writing about her contributions to family law.

Although I was no longer with the Law Department, given my time there as the Brooklyn Borough Chief of the Family Court Division, my former supervisors there added me to the email chain and, as they say, the rest was history. I realized the importance of telling this story from a case analysis point of view. Once invested in the project, my court attorney joined me and together we wrote these articles, which help highlight Judge Jane Bolin's importance to the Family Court, to diversity and to the accomplishments of women's rights.

The NYC Law Department has an award named in her honor:

The Jane M. Bolin Diversity Leadership Award recognizes and celebrates the outstanding contributions and significant impact by an exceptional member of the Law Department in promoting and advocating the office's diversity goals.

Jane Bolin served as an attorney here from 1937 to 1939. A true trailblazer, Bolin became the first African American woman to serve as an Assistant Corporation Counsel. Later, she became the first female African American jurist in the United States when she was appointed as Justice of the Domestic Relations Court of the City of New York (renamed the Family Court in 1962). This award recognizes her contributions in advocating for, and advancing, diversity.


