

## March 7, 2025 Midyear Report Report from District 3 Honorable Lisa James-Beavers

The members of District 3 have been very busy meeting to plan our Color of Justice program, which will be held on April 3, 2025, at the Mitchell H. Cohen U.S. Courthouse in Camden, NJ. The Committee consists of: Honorable Kim Belin, Administrative Law Judge; Elizabeth Davies, Deputy Attorney General; Erin Gallagher, Esq.; Honorable Rosemary Gambardella, U.S. Bankruptcy Judge; Gina Labrecque, Deputy Attorney General; Honorable Lourdes Santiago, Judge of the Superior Court (ret.); Honorable Siobhan Teare, Judge of the Superior Court (ret.); Honorable Karen Williams, Judge of the District Court of NJ; me as Chair; and Laurie Denham, NAWJ Executive Director.

The program will consists of four parts: a keynote speaker, Honorable Michael Noriega, Justice of the New Jersey Supreme Court; a panel on civics featuring Gina Labrecque as moderator and U.S. Bankruptcy Judge Chrstine Gravelle, Superior Court Judge Charles Dortch; and Superior Court Judge Gwendolyn Blue; a panel on careers in the law moderated by Deputy Attorney General Elizabeth Davies and featuring Administrative Law Judge Kim Belin, Assistant U.S. Attorney Jason Richards, Paralegal Rucha Dubli, and Assistant Deputy Public Defender Felicia Felder; and the last part will be lunch. There will be opening remarks by the Chief Justice of the U.S. District Court Renee Bumb, U.S. District Court Judge Karen Williams and me. We will attempt to make the program as interactive as possible and have the students ask and answer questions. The theme is **"Empowering Youth to Become Informed Leaders."**  In addition, I attended the following events and engaged in the following activities after attending the NAWJ conference in October:
