Judge Carol King has agreed to share her time with us to pause - take a deep breath- and share her thoughts and experience on secondary trauma and self-care as our guest speaker on "The Art of Self Care"!

Judge King originally developed her presentation on "The Art of Self Care" several years ago as a "conversation starter" because she felt the issue was not being discussed or considered in most law firms or courtrooms and because she wanted people to start thinking about self-care in their career journey. While she always says that she is not a psychologist or social worker, nor an expert in trauma, she *is* a Judge with real life experiential "expertise" who is willing to engage us in dialogue about these issues.

I agree with Judge King that the issue of self-care is very important for judges in many different courtroom settings, where we hear traumatic stories day in and day out, we fear for our own safety and that of our court staff and other people in our courtrooms, we see escalating violence and attacks on judges in the news more and more frequently. Judge King invites us to pause - take a deep breath- and share our thoughts and experiences with each other through the lens of her presentation.

I will be sending a Zoom link for the presentation, scheduled for next Friday, March 22, at 6:30 pm EST, intended to give you time to return home and begin to unwind from the week with a glass of wine or cup of tea in hand and join us in conversation of "self-care"!

*Judge Beverly Cutler has written a very informative article which was recently published in CONTERBALANCE (COUNTERBALANCE, Volume 38, Issue 1, Winter 2024 on the NAWJ web site under NEWS and directly here) describing the wonderful work that she and other NAWJ members are doing to mentor displaced Afghan Judges. It was March 2022 when our International Director, Judge Lisa Walsh, contacted Judge Cutler regarding the first Afghan judges arriving in the DC area. Judge Walsh cobbled together a full Mentor Team for the DMV area to assist them. Two years later, 14 Afghan women judges have resettled in various parts of NAWJ District 4, with more coming, and mentoring efforts continue with Judge Cutler serving as the liaison for this initiative in District 4. Much is needed to support our "Sisters-In-Law" during this most difficult time, from something as small as donated household items to networking support for more complex issues of housing and employment.
