Memphis Municipal Court **Judge Teresa Jones** died on January 2 after a battle with cancer. She was 61. Judge Jones began serving in Division One of Memphis Municipal Court on January 15, 2019, after having been appointed by Memphis Mayor Jim Strickland. She won election to that seat in October 2019.

**Judge Angelita Blackshear Dalton** is Judge of Division II of the Davidson County Criminal Court. Judge Dalton assumed the bench after being appointed by Governor Bill Haslam to succeed Retired Judge J. Randall Wyatt. Judge Dalton is also on the NAWJ 1st Time Attendees Committee



**Judge Ana L. Escobar** was elected to General Sessions Court, Division III, taking the bench in 2018, where she is currently serving as one of three judges that preside over the court's domestic violence cases. Judge Escobar is also on the NAWJ International Event Committee.

**Judge Anne C. Martin** was sworn in as a judge on the Davidson County Chancery Court, Part II, on September 1, 2018. On November 1, 2019, the Tennessee Supreme Court appointed Chancellor Martin as the Business Court Docket judge. She is also is volunteering for the NAWJ Hospitality Committee.
