Michigan:


1. Color of Justice:



3. Member Accomplishments/highlights:

Michigan is pleased to add the following members to its roster since February 1, 2021: Supreme Court Justice Megan Cavanaugh, and University of Detroit Mercy law students Samantha Coulter, Danielle Anderson, and Jocelyn Flemons.

In other news, Wayne County Circuit Judge Miriam Bazzi is the recipient of the Hon. Kirsten Frank Kelly Award from the Women Lawyers Association of Michigan-Wayne region. The Honorable Kirsten Frank Kelly Award is presented to a WLAM-Wayne member in good standing who not only contributes to WLAM-Wayne, but has exemplified dedication to leadership and actively champions justice in the Wayne County legal community. This award will be presented at the WLAM-Wayne Region Annual Meeting in May on Zoom.

Judge Bazzi and Michigan co-chair Zenell Brown recently presented at the Michigan Supreme Court's all court conference. Their topic was creating diversity and inclusion plans or strategies for courts.

In recognition of Arab American Heritage month, Judge Bazzi also penned an article on contributions of Arab American judges of metro Detroit, past and present. Her article is attached.

On April 21, 2021, Michigan co-chair Zenell Brown was recognized by receiving the Sojourner Truth Award from The National Association of Negro Business and Professional Women's Clubs. The Sojourner Truth Award is the pinnacle of The National Association of Negro Business and Professional Women's Clubs, Inc. Founders' Day which is celebrated each April. The Detroit Club's 2021 Founders' Day Co-Chairs were Jeanette Dunmore and Patricia Moncrease.

Judge Michelle Rick will be honored at the Women Lawyers of Michigan annual meeting in June. She is receiving the Mary S. Coleman Award. Justice Coleman was the first female justice on the Michigan Supreme Court. The award is given to a current or former member of the Michigan federal, state, or tribal judiciary whose leadership, talent, and significant contributions to women provide a role model for women in the profession and women in general. Last year's award was presented to Michigan Supreme Court Justice and NAWJ member Bridget McCormack. NAWJ lifetime member Judge Susan Moiseev was the first recipient of the award in 2012.

CJ Bridget McCormack, together with Arkansas Justice Rhonda Wood, Justice Eva Guzman of Texas and Justice Beth Walker of West Virginia have a podcast, aptly titled "Lady Justice: Women of the Court".
