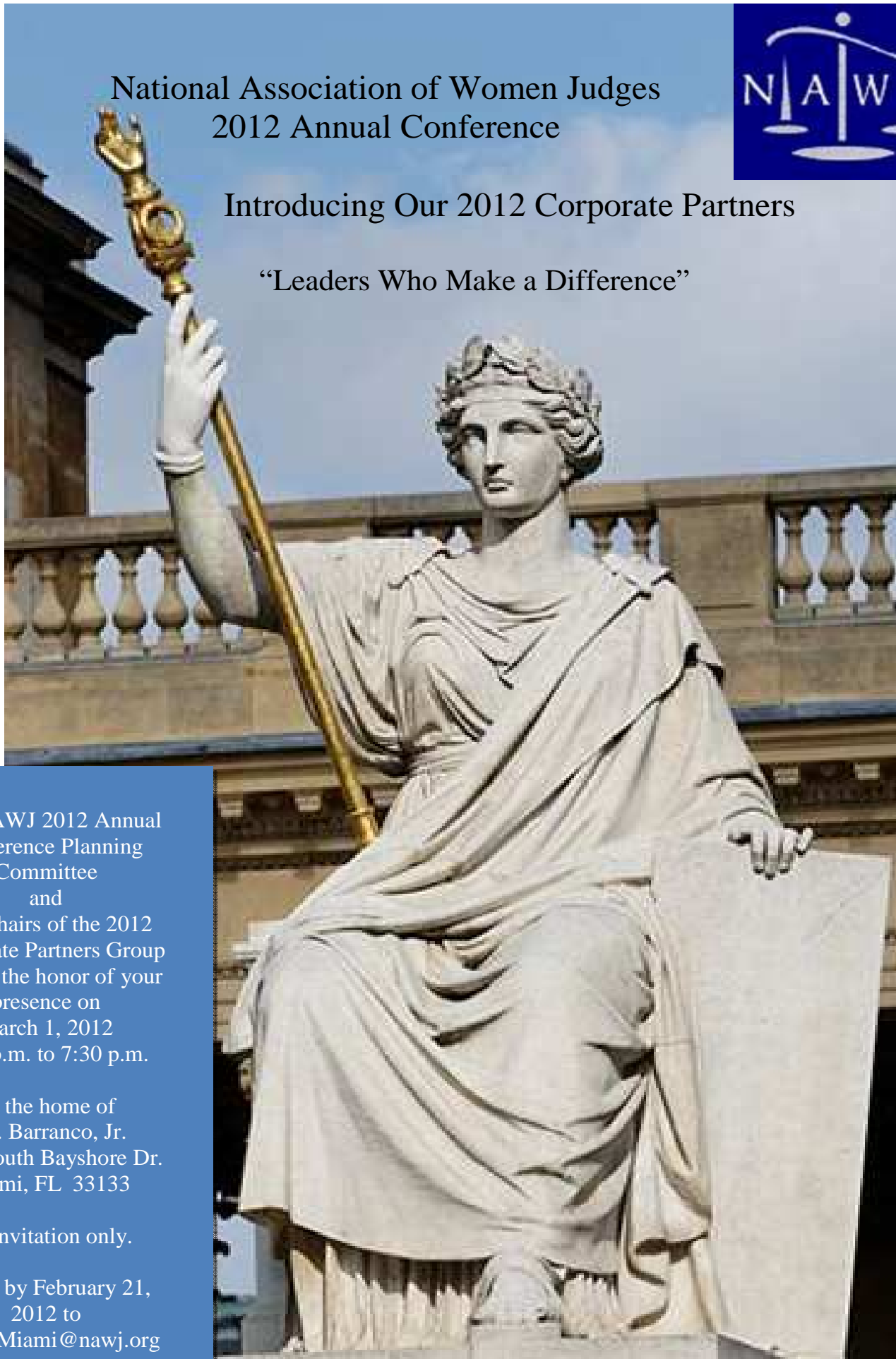

## **ANNOUNCING THE 34<sup>TH</sup> ANNUAL CONFERENCE OF THE NATIONAL ASSOCIATION OF WOMEN JUDGES TO BE HELD IN MIAMI BEACH, FLORIDA ON NOVEMBER 7<sup>TH</sup> TO 11<sup>TH</sup>, 2012.**

This premier women judge's event will bring together local, state, national and international judges, civic, academia, corporate, governmental, community leadership, service professionals, students and many other exciting and diverse groups.

Our 2012 National Association of Women Judges Annual Conference is expected to include over 500 registered participants and 1500 attendees through its three day duration.
