NAWJ Holds Chiefs Luncheon with the CCWI

On Tuesday, July 11, 2006, a Luncheon was held between women leaders of the national judiciary and members of the Congressional Caucus for Women's Issues. NAWJ's leadership was well represented by Marjorie Carter, Nan Duffly, Sue Yang and Joan Churchill, together with Past Presidents Joan Dempsey Klein, Gladys Kessler, Christine Durham, Bernice Donald, Brenda Murray, and Noel Kramer.

Our historic Capitol Luncheon drew an attendance of 25 Chief Justices, Associate Justices, Chief Judges, and other judges from across the country, together with 18 Congresswomen representing states from California to New York, including House Minority Leader Nancy Pelosi and Caucus Co-Chair Hilda Solis. We were particularly pleased by the bipartisan interest in working with NAWJ and the unexpected and welcome attendance of a number of Congresswomen—several of whom, we were told, do not ordinarily attend Caucus events. Twelve of the judges were also able to participate in a highly productive meeting later that afternoon with Senator Dianne Feinstein.

It is a tribute to NAWJ and those judges who were able to attend that we were able to stimulate such an impressive turn-out by Caucus members. The Congressional response certainly owes in large part to two "Dear Colleague" letters--the first signed by Reps. Hilda Solis (D-CA), Deborah Pryce (R-OH), and Stephanie Tubbs Jones (D-OH), who were then joined in the second letter by the Caucus Republican Co-Chair Ginny Brown-Waite (R-FL). It was, however, NAWJ's ability to marshal such an impressive, nonpartisan array of outstanding women judicial leaders that seems to have convinced those Congressional leaders to sign the letters and persuaded their colleagues that this was a meeting they did not want to miss. To the surprise of the Caucus organizers, the Congresswomen not only they came, but they stayed. We could not have had a warmer welcome by Rep. Solis on behalf of the Caucus, and by the unexpectedly active participation and generous remarks of Congresswoman Nancy Pelosi.

Several NAWJ leaders and a number of Congresswomen, including Rep. Solis and the upcoming 110th Congress Caucus' Democratic Co-Chair, Rep. Lois Capps (D-CA), agreed that we should hold this luncheon again next year, with maximum notice to all invitees and pursuant to a mutually agreed-upon substantive agenda. Caucus leaders were receptive to the idea of creating a small committee of representatives from the two branches to hammer out the appropriate scheduling, format and substance of the meeting. We are currently in the process of putting the committee together, and have every hope that the July 11th Luncheon will be the First Annual National Women's Judicial/Legislative Luncheon.
