Only voting members in good standing are eligible to hold office, which includes retired judges who remain subject to the canons of judicial conduct

The President-elect must have served a term as Vice President, Treasurer, or Secretary, or as Chair of the Projects Committee, the Resource Development Committee, or the Finance Committee. Candidates for the position of president-elect should also address their plans to continue and build on NAWJ's existing programs and implement NAWJ's Long-Range Strategic Plan (2007-1012), which can be found at NAWJ's website.

# From NAWJ Bylaws:

"The Nominating Committee shall present at least one (I) nominee for each officer's position. A nomination for each officer's position also may be submitted in writing to the Nominating Committee by petition of no less than nine (9) voting members of the organization at least **sixty (60) days** prior to the Annual Meeting. The list of nominees for each position designated by the Nominating Committee and by petition shall be circulated to the voting membership at least **thirty (30) days** prior to the Annual Meeting. Nominations for all officer positions may also be made by voting members from the floor at the Annual Meeting provided such nominees' names have previously been submitted to the Nominating Committee and the Nominating
