NAWJ Membership Reaches Five-Year High

An organization that began with only a handful of women bound by their common purpose to support each other and to support diversity and gender equity in the judiciary has reached a five year high in membership.

Jeff Groton, the Chief Operating Officer, reported that January 2007 brought NAWJ membership to 1204 members. This is the first time in five years that membership in the organization has topped 1200.

Judge Brenda Stith Loftin, President of the NAWJ, said, "This represents the recognition that the programs and services we provide to our members are meeting a special and unique need within the judiciary."

The signature programs of NAWJ like the Genome Justice Project, Women in Prisons project and Color of Justice are designed to promote the organization's mission, which includes promoting diversity on the bench as well as ensuring equal access to justice.

"Certainly, our membership committee members have worked very hard," added Dru Stender Ramey, the organization's Executive Director. "The efforts of our various specialty courts, in particular, have given new emphasis to making our programs and services available to judges who had previously perhaps been unaware of NAWJ's value to them in their jurisdiction."

This year a special outreach effort was made to judges in the federal and administrative judiciary. There has also been a concerted focus on attaching judges to their regions for some of the outstanding regional programs now being offered by the organization.

The next milestone is to achieve 1250, which represents a matching grant challenge established by one of NAWJ's Landmark Sponsors.
