**Loretta A. Tuell**, Partner, Anderson Tuell, LLP, lawyer and legislative advocate on behalf of Indian tribes; in Washington, DC.

Margaret Brent was the first woman lawyer in America, arriving in the colonies in 1638. She was a master negotiator, an accomplished litigator, and a respected leader. Ms. Brent was involved in 124 court cases over eight years and won every one. In 1648, she formally demanded a "vote and voice" in the Maryland Assembly, which the governor denied. Over 250 years later, *Harper's* magazine noted: "by this action, Margaret Brent undoubtedly placed herself as the first woman in America to make a stand for the rights of her sex."
